The Bank hereby reports that, on March 10, 2024, a notification was received from Y. D. More Investments Ltd. ("More Investments") stating that it had become a material holder in the Bank. At the date of receiving the notification, More Investments was the holder of 45,956,522 ordinary A shares of the Bank, constituting 3.72% of the Bank's issued share capital and its voting rights (3.70% on a fully diluted basis).

Presented below are detail's regarding More Investments in accordance with Regulation 33 (f) of the Securities (Immediate and Periodic Reports) Regulations, 1970:

More Investments is a public company controlled jointly by Messrs. Eli Levy (ID No. 039038260), Yosef Levy (ID No. 055311187), Benjamin Meirov (ID No. 051376754), Yosef Meirov (ID No. 052364395), Michael Meirov (ID No. 031720915), and Dotan Meirov (ID No. 037560158), who together hold 54.04% of the issued and paid-up share capital of More Investments.

Mr. Eli Levy's holding in More Investments is through a company that is wholly (100%) owned by him, Elldot Ltd. (Private Company No. 515616761).

Mr. Yosef Meirov has a direct holding in More Investments as well as a holding through B. Y. M. Mor Investments Ltd. (Private Company No. 515566750) ("B.Y.M."), which is held by Yosef Meirov (50%), Dotan Meirov (25%) and Michael Meirov (25%). The holdings in More Investments of Michael Meirov and Dotan Meirov (the sons of Benjamin Meirov, one of the owners of More Investments) are solely through B.Y.M.
