On June 4, 2023, the Bank was sent a copy of the petition for recertification of a class action that was filed with the Central District Court against Discount Bank and additional banks ("the Petition").

It is alleged in the Petition, inter alia, that the banks were required to inform customers with a credit balance on their account that they were able to transfer the funds to a daily interest-bearing deposit or that they should have automatically granted interest on the credit balance to those customers.

The amount of the group damages being claimed in the petition is in excess of NIS 1 billion. The petition has not yet been furnished to the Bank as required by law.
