On July 24, 2023, a claim and a petition for its approval as a class action, which had been filed in the Tel Aviv District Court ("the Petition") against Israel Discount Bank and additional banks ("the Respondents"), were delivered to the Bank.

It is alleged in the Petition that the Respondents do not disclose to their customers, who contact them via the Internet/the app requesting to place their funds on deposit, that the interest offered to them over said channel is lower than the interest offered/customary at the Respondents in relation to the same type of deposit which is given to a customer who makes contact over another channel or who bargains with the Bank.

The amount of the damages claimed by the whole class amounts to NIS 984 million and is attributable to all the respondent banks collectively.
