On August 7, 2023, a copy of a claim and a petition for its approval as a class action ("the Petition") were sent to the Bank. The claim and Petition were filed in the Tel Aviv District Court against Israel Discount Bank and additional banks ("the Respondents"). It is alleged in the Petition, inter alia, that the Respondents require borrowers taking a mortgage to insure the mortgaged property under a building insurance policy and do not inform the borrowers that there is no legal obligation to insure the property in order to take a mortgage on it. It should be noted that the Petition has not yet been served on the Bank, as required by law.
