Further to the Immediate Reports from December 22, 2022 (reference no.: 2022-01-154045) and from January 3, 2023 (reference no.: 2023-01-001587, the Bank hereby provides an update that this morning the Ministry of Finance announced that the Minister of Finance has decided to exercise his power to change the definition in the regulations of a "bank with wide-ranging activity", in such a manner as to apply to the Bank; the Ministry of Finance also announced that the Minister has sent the draft regulations to the Governor of the Bank of Israel, who has exercised his power to prescribe provisions therein, and now the Minister will send the regulations to the Knesset Finance Committee for approval. The Ministry of Finance further announced that it is intending to appoint a ministerial team the conduct a wide-ranging examination into the large institutional bodies' control of credit card companies. The Minister went on to announce that he intends to issue a law memorandum that will revoke the obligation of the banks to reduce the facilities that the credit card companies grant their customers.
