On April 16, 2024, a claim and a petition for its certification as a class action ("the Petition") were delivered to the Bank. The claim and Petition were filed in the Central District Court against Israel Discount Bank and additional Mercantile Discount Bank Ltd. ("the Banks"). It is alleged in the Petition, inter alia, that, when a transfer in foreign currency is received via the SWIFT system, the Banks do not immediately credit the customer's account, but only do so after some time has elapsed which, it is alleged, is unreasonable and that this delay causes harm to the customer. The amount of the group damages being claimed is in excess of NIS 2.5 million.
